#### **RESOLUTION NO. 1464**

A RESOLUTION OF McKEAN TOWNSHIP, ERIE COUNTY, PENNSYLVANIA AUTHORIZING THE ADVERTISEMENT OF THE TOWNSHIP'S INTENT TO APPOINT A FIRM OF CERTIFIED OR COMPETENT PUBLIC ACCOUNTS TO MAKE AN EXAMINATION AND AUDIT OF ALL THE ACCOUNTS OF THE TOWNSHIP FOR FISCAL YEAR 2018.

WHEREAS, Section 917(b)(1) of the Second Class Township Code authorizes a Board of Supervisors to appoint a firm of certified or competent public accounts to replace a Township's elected Auditors for purposes of making an examination and audit of all the accounts of a Township; and

WHEREAS, Section 917(b)(1) of the Second Class Township Code further authorizes a Board of Supervisors to determine the compensation for such firm of certified or competent public accounts; and

WHEREAS, Section 917(b)(2) of the Second Class Township Code requires that at least thirty (30) days prior to any vote to appoint a firm of certified or competent public accountants to replace the elected Auditors, a Board of Supervisors must advertise in a newspaper of general circulation the intent to appoint a firm of certified or competent public accountants to replace the elected Auditors; and

WHEREAS, the McKean Township Board of Supervisors believes that the consideration of the appointment of a firm of certified or competent public accountants to replace the elected Auditors is in the best interest of the Township.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of McKean Township, Erie County, Pennsylvania, as follows:

- 1. The McKean Township Board of Supervisors hereby authorizes the advertisement of the Township's intent to appoint a certified public accountant firm at the 2019 organization meeting to replace the Township's elected Board of Auditors to audit and make an examination of the accounts of the Township for fiscal year 2018, and the preparation of a Resolution regarding the same.
- 2. A legal advertisement shall be placed in the *Erie Times-News*, a newspaper of general circulation in the Township, notifying the public of the date, time, and location of the said organization meeting.
- 3. The appropriate Township personnel are hereby authorized and directed to take all actions necessary to carry out the purposes of this Resolution.

RESOLUTION APPROVING THE ASSIGNMENT OF CDBG PROGRAM INCOME MONIES TO THE FY 2015 CDBG FUNDED

#### SINGLE FAMILY HOUSING REHABILITATION PROJECT

**WHEREAS**, the Township of McKean has been designated a CDBG "entitlement" municipality pursuant to the provisions of PA Legislative Act 179 of 1984; and

WHEREAS, such designation entitles the Township to receive an annual allocation of Community Development Block Grant funds from the PA Department of Community and Economic Development (DCED) to undertake housing and community development projects which will principally benefit low-to-moderate income persons; and

**WHEREAS**, the Township is using its FY 2015 CDBG monies to rehabilitate several homes of low-to-moderate income families for compliance with HUD Housing Quality Standards; and

**WHEREAS**, the assistance is being provided as a five (5) year deferred payment loan, 20% of which is forgiven each year until a zero (0) balance is reached at the end of the fifth year, thereafter releasing the property owner of any dollar obligation. If the property owner sells, vacates or rents the house before the five-year period expires, the pro-rated balance of funds must be paid back to the County on behalf of the Township; and

**WHEREAS**, a house located at 10550 Oliver Road, McKean PA was rehabilitated with FY 2015 CDBG funds and subsequently sold prior to five-year expiration period resulting in funds being returned to the County totaling \$11,532.00; and

**WHEREAS**, such funds are considered "program income" monies and are to be used by McKean Township to undertake CDBG eligible and fundable activities; and

**WHEREAS**, the Township desires to have these monies assigned back to the FY 2015 CDBG funded Single Family Housing Rehabilitation Project which will provide for the rehabilitation of single family, LMI owner-occupied housing units for compliance with HUD Section Housing Quality Standards.

**NOW THEREFORE, BE IT RESOLVED** by the McKean Township Board of Supervisors that the Township hereby approves the assignment of program income monies totaling \$11,532.00 to the FY 2015 Single Family Housing Rehabilitation Project as noted above.

# RESOLUTION NUMBER 1467-2018 RESOLUTION APPROVING A REVISION TO MCKEAN TOWNSHIP'S FY 2016 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

**WHEREAS**, the Township of McKean is entitled to receive an annual allocation of Community Development Block Grant (CDBG) funds from the Pennsylvania Department of Community and Economic Development (PA DCED) pursuant to the provisions of PA Act 179 of 1984; and

**WHEREAS**, the Township received \$86,272 in FY 2016 CDBG funding and previously resolved that the monies be used for the following:

- \$77,672.00 Purchase and installation of two (2) pavilions, picnic tables and grilles for Idyll Whyle Village Mobile Home Park (*Idyll Whyll Village Mobile Home Park Recreation Project Phase II*)
- \$ 8,600.00 General Program Administration; and

**WHEREAS**, the Idyll Whyll Phase II Project has been completed at a cost of \$69,747.20 leaving a balance of \$7,924.80; and

**WHEREAS**, the Township desires to utilize these residual monies to supplement its FY 2015 CDBG funded Single Family Housing Rehabilitation Project which will provide for the rehabilitation of approximately five (5) housing units for compliance with HUD Housing Quality Standards; and

**WHEREAS**, utilizing residual funding from one fiscal year to supplement an existing activity in another year constitutes a "revision" to the CDBG program which requires approval by the governing body and the submission of applicable documentation to the PA Department of Community and Economic Development.

**NOW THEREFORE BE IT RESOLVED** that the McKean Township Supervisors desire to revise its FY 2016 CDBG program as follows:

- ✓ Reduce the amount of FY 2016 funding for the Idyll Whyll Village Mobile Home Park Recreation Project Phase II from \$77,672.00 to \$69,747.20, and
- ✓ Utilize the residual funds totaling \$7,924.80 to supplement the FY 2015 CDBG funded Single Family Housing Rehabilitation Project.

**BE IT FURTHER RESOLVED** by the McKean Township Supervisors that:

- ✓ All other terms and conditions regarding the FY 2016 CDBG program not affected by this revision shall remain in full force and effect; and
- ✓ The Erie County Department of Planning is authorized to submit all necessary documentation to the PA Department of Community and Economic Development to effectuate the program change.
