## **SPECIAL MEETING OF McKEAN TOWNSHIP SUPERVISORS**

### **CALL TO ORDER**

A special meeting of the Board of Supervisors was called to order on April 18, 2023 by Chair Janice Dennis at 3:00 p.m. as previously advertised and took place at the McKean Township Municipal Bldg.

### **ROLL CALL**

Members present were Janice Dennis, Brian Cooper, Ronald Bole, and Mark Corey-Engineer.

The purpose of the meeting was to receive and consider bids for the Fry Road Bridge No. 1 Replacement Project and any other business as may come before the Board.

### **Bids were opened and read as follows:**

#### **McLallen Construction, Inc., Erie, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$156,699.00. It was noted that the bid bond was included and the anti-collusion affidavit.

#### **Shingledecker's Welding, Inc., Franklin, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$179,000.00. It was noted that the bid bond was included and the anti-collusion affidavit.

#### **Konzel Construction Company, Inc., Erie, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$219,110.00. It was noted that the bid bond was included and the anti-collusion affidavit.

#### **Ray Showman Jr. Excavating, Inc., Waterford, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$222,736.50. It was noted that the bid bond was included and the anti-collusion affidavit.

#### **Amendola Construction & Maintenance, Erie, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$170,100.00. It was noted that the bid bond was included and the anti-collusion affidavit.

**Northrock Construction, Inc., Cranberry, PA**

Construction of an Aluminum Structural Plate Box Culvert Structure over an unnamed tributary to Elk Creek at a total bid price of \$166,727.00. It was noted that the bid bond was included and the anti-collusion affidavit.

Ron Bole moved to award the bid to McLallen Construction at a total bid price of \$156,699.00, second by Brian Cooper and passed by unanimous roll call vote.

It was noted that one bid was opened and read on April 11, 2023 at the Harborcreek Township Municipal Building as follows:

Suit-Kote Corporation, Meadville, PA

190,000 SY Single Asphalt Seal Coat complete in place at \$1.70 per square yard

Brian Cooper moved to award the bid to Suit-Kote for 190,000 square yards of Single Asphalt Seal Coat complete in place at \$1.70 per square yard, second by Ron Bole and passed by unanimous roll call vote.
