REGULAR MEETING OF McKEAN TOWNSHIP SUPERVISORS

CALL TO ORDER

A regular meeting of the Board of Supervisors was called to order by Chair Janice Dennis as previously publicized and took place July 6, 2023 at 7:30 p.m. at the McKean Township Municipal Bldg.

ROLL CALL

Members present were Jan Dennis, Brian Cooper (via telephone), and Ron Bole.

CITIZEN COMMENT—AGENDA

Mr. and Mrs. Chris Haskins of 8411 Bargain Road stated that he received documents from the PADEP relating to the Bizzarro property on Bargain Road. These documents noted various violations from 1982 to 2015. Mr. Haskins stated that the Bizzarro's were hit hard from the PADEP for burning. Other concerns were oil from vehicles, acid from batteries, there was three waste barrels on property, and runoff into tributaries to Elk Creek. These documents show that Bizzarro does not follow rules. They do not have a permit from the DEP for a junkyard. He also noted that there are endangered species on this property.
