### **COLONIAL VILLAGE SUBDIVISION SEWAGE TREATMENT PLANT REPLACEMENT PROJECT**

#### **RESOLUTION FOR PLAN REVISION**

#### **RESOLUTION NO. 1665**

RESOLUTION OF THE SUPERVISORS OF McKEAN TOWNSHIP, ERIE COUNTY, PENNSYLVANIA (hereinafter “the municipality”).

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the “Pennsylvania Sewage Facilities Act,” as amended, and the Rules and Regulations of the Department of Environmental Protection (Department) adopted thereunder, Chapter of Title of the **Pennsylvania Code**, requires the municipality to adopt and Official Sewage Facilities Plan providing for sewage services adequate to prevent contamination of waters and/or environmental health hazards with sewage wastes, and to revise said Plan whenever it is necessary to meet the sewage disposal needs of the municipality, and

WHEREAS, Township Engineer Mark J. Corey, P.E. of Mark J. Corey & Associates, has prepared the Colonial Village Subdivision Sewage Facilities Plan Special Study which provides for sewage facilities in a portion of McKean Township, and

WHEREAS, the alternative of choice to be implemented is the replacement of the existing Colonial Village Subdivision sewage treatment plant and extension of public sanitary sewer service to a portion of Bargain Road. The key implementation activities and dates include:

- Sewage Facilities Planning Approval: July 31, 2025
- Design/Permitting: July 31, 2025
- Bidding/Contracting: August 31, 2025
- Construction: February 28, 2026
- Project Completion: March 31, 2026

WHEREAS, McKean Township finds that the Facility Plan described above conforms to applicable zoning, subdivision and other municipal ordinances and plans and to a comprehensive program of pollution control and water quality management.

NOW, THEREFORE, BE IT RESOLVED that the Supervisors of the Township of McKean, County of Erie, hereby adopt and submit to the Department of Environmental Protection for its approval as a revision to the "Official Plan" of the municipality, the above referenced Facility Plan. The municipality hereby assures the Department of the complete and timely implementation of the said Plan as required by law (Section 5, Pennsylvania Sewage Facilities Act, as amended).
